I truly believe that the CD3 Initiative is one of the most interactive ways to educate yourself on whether you should pursue law. For me it certainly was. I find the purpose of the initiative to be extremely insightful. Nowadays I think that we may all take part in the initiative benefits in the sense that civil discourse and discussions are something the world needs at times. We should not resort to screaming matches and petty remarks, rather, we should form our opinions on factual evidence and logical arguments. Sometimes when we get too caught up in our emotions, we may overlook important details. Being civil is what makes our arguments commendable and heard.
